Details of Service	<p>The Children's Disability Network Team Lead Agencies incorporating Avista, CRC, HSE and St Michaels House have joined together as a Consortium for the CHO Dublin North City and County (CHODNCC) area to recruit for a number of Healthcare Professionals.</p> <p><i>Children's Disability Network Teams are inter-disciplinary teams of Healthcare Professionals who work with children and young people (0-18 years) with complex needs, providing a Family Centred service as close to the child/young person's home as possible.</i></p> <p><i>Children's Disability Network Teams provide a range of universal, targeted and specialised supports for children/young people with complex needs arising from disability. In line with Slainte Care the Children's Disability Network Teams also work closely with Primary Care and Child and Adolescent Mental Health Services to provide integrated care services. The Children's Disability Network Manager provides leadership and guidance for each team.</i></p>
Job Purpose	<p><i>To work as a Senior Grade Psychologist in line with team service plans and objectives and within established professional standards, guidelines and policy.</i></p> <p><i>To support assessment and interventions in line with principles of Children's Disability Network Teams.</i></p> <p><i>To work as part of the Children's Disability Network Team to provide therapeutic services to children and young people (0 -18 years) with a range of complex needs arising from a disability and whom are living within the Community Health Organisation. There will be a strong emphasis on interdisciplinary team working and family centred practice as per the principles of Progressing Disabilities for Children and Young People.</i></p>

<p>Key Duties and Responsibilities</p>	<p><u>Clinical Duties</u></p> <ul style="list-style-type: none"> • Work as a member of an Interdisciplinary Team • Be responsible for the delivery of professional psychology services appropriate to the post in line with best practice. • Work within limits of professional competence in line with principles of best practice, professional conduct, and clinical governance. • To carry an appropriate clinical caseload assigned by CDNM, based on the clinical need of the CDNT, in line with professional practice and in collaboration with clinical supervisory support from the Principal Psychologist. • To develop ongoing clinical expertise in line with the needs of the service and the priorities of the Children's Disability Network Team. • Formulate and implement plans for psychological therapeutic intervention or management based on an appropriate conceptual framework, working in home and clinical settings as appropriate. • Comply with the GDPR policy of the organisation in relation to the management and storage of service user information • Participate in the supervision of basic grade psychologists and the training of psychology students as necessary. • Initiate, implement and monitor interventions as appropriate to the professional standards of a psychologist. • To undertake assessment, therapy, appropriate interventions, and preventative programmes in accordance with the professional competence of clinical psychologists. • To provide professional reports and information to other professional staff and such other reports as appropriate. • Represent a professional viewpoint in relation to nationally accepted good practice, promoting high levels of ethical standards and professional conduct. • To contribute and support development and monitoring of a child's Individual Family Service Plan (IFSP) in line with family centred practice and PDS principles. • Undertake a key worker/key contact role as required <p><u>Education & Training</u></p> <ul style="list-style-type: none"> • Contribute to and participate in Psychology and interdisciplinary education sessions.

- To participate in regular clinical professional supervision and continued professional development.
- Engage in the education of colleagues, student Psychologists, Service Users, and other health care professionals.
- To participate in the development and delivery of training/education to children, families and staff as required, including those from external agencies.
- To develop skills and abilities in the training and implementation of required restrictive practices to staff and family members as appropriate.
